Progress Monitoring Plans In-service training of staff and RTI training: Low achieving students will all receive a PMP that outlines what the school and the parents are doing to assist the student in succeeding academically. This will create a partnership amongst the parents and school to help the struggling students and create a pathway of success for them.

Champs Training: The teachers and staff will be trained on the CHAMPS Behavioral system, where they will share the discipline plan with the parents to decrease student suspensions. The common behavioral plan will be well understood by both parties and will also create an open dialogue between home and school to identify and resolve the targeted unwanted behaviors. Both the avenues will serve as resources for each other.
