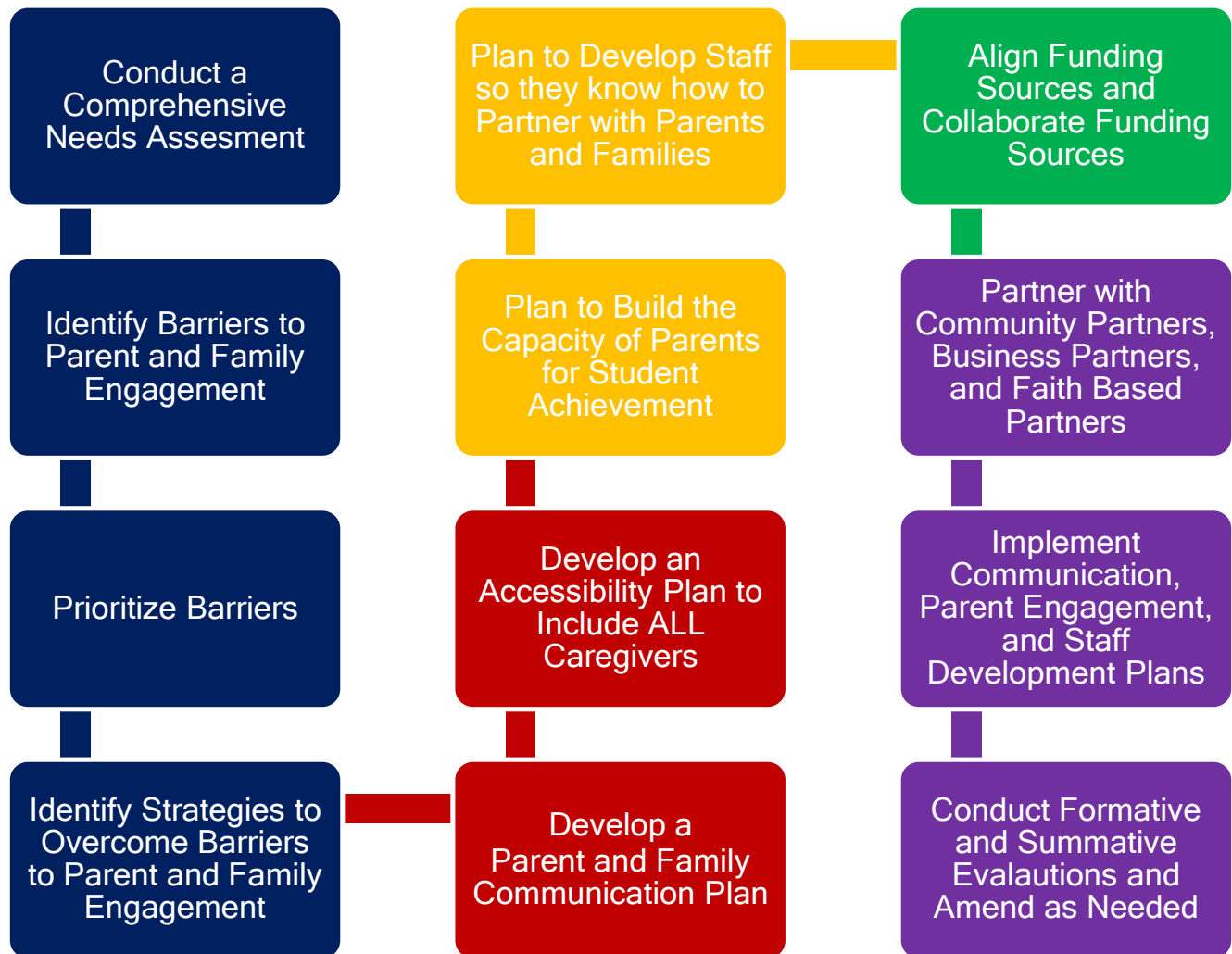

Annual	130	Parents were more knowledgeable about the resources available to them at school.
Developmental Meeting	23	Parents felt like resourceful stakeholders and had open discussions about ways to better the parent involvement at the school. These parents took leadership roles in advocating parent participation to other parents.
Open House	143	Parents were more involved in school activities and were well informed about academic and behavioral expectations. They were more involved than previous

		years, which showcased in the school's academic success.

The activities were a hit with 3-5 grade students and parents took a keen interest in completing activities with their children. We received many completed projects for several days after the family night, proving that parents and children were working on them together even after that evening.
Black History and FSA Writes	115	Big parent participation is always seen during Black History Night. Students and parents played the informational games together and were fully engrossed in exchanging relevant history information with each other. Activity sheets were passed out and students completed them with their parents and brought them back to school.
FSA Family Night	46	FSA family nights are information sessions and parents took a keen interest in finding important resources for their students to be successful. The evidence of success was their continuous partnership with teachers until the assessments were over. The school had to only hold few make up sessions as our parents made sure that their children attend school regularly and on time. The tardies for 3-5 students decreased after the parents understood the importance of their children to be on time for FSA preparation.
Summer Information Family Night	120	Parents were given summer school information, handouts for activities to do during summer, and other summer resources. It was a huge success as all parents walked out with some relevant information that was useful to them.

Arts Showcase	120	The Arts showcase was a also a part of the Summer Information Session to provide hands on experience to parents about working together with their kids during summer time. Parents created arts projects and were allowed to take the complete and incomplete pieces home for summer.

Barriers

1. Barrier 1: Lack of transportation (Economically disadvantaged parents). Students of these parents rode the school buses from different parts of Jacksonville. Parent engagement was more seen by parents living close by or in the neighborhood.
2. Barrier 2: Working parents (scheduling time to come to school), especially single parents and parents working two jobs.
3. Barrier 3: Limited Literacy and parents not too keen in their child's academic success. It was very difficult to reach out to certain parents, also due to constant changing of phone numbers and not getting any response back to written meeting requests.

1. Barrier 1 - Providing transportation to the parents requesting for assistance.
2. Barrier 2 -Offering events at different times to accommodate working parents.

All families will fill out a language survey. This will assist us in determining if any translations are needed. All information in currently printed in the English language. 4. Barrier 4: For migratory students the school will create a positive and welcoming classroom environment by modeling respect for differences, and sharing experiences and values. The

school will reach out to the families of migrant students and help them become familiarized and comfortable with the school. Creating a list of helpful social service resources and advocacy organizations those families can call on.

School will utilize quarterly report cards, and iReady parent reports with detailed description of performance levels and goals to obtain. Resources to reach those goals will be provided along with the support needed by parents to support their children.</p>

<p>(1) The school will provide opportunities for regular meetings for parents to formulate suggestions and participate in decision-making process. Throughout the year, various parent workshops will be held focusing on specific academic areas. Parents will be notified about these workshops via flyers and the school website. In addition, flyers will go home a week prior to each workshop and/or event to remind parents of the upcoming event. After each event an opinion sheet will be provided to the parents to voice their concerns, opinions, and suggestions.</p> <p>(2) Parents will participate in the decision making via PTA meetings, Board Meetings, surveys, and the school also has a suggestion box in the parent involvement room.</p>
